
2022 County Health Rankings: By Maryland Jurisdiction

Housing and Urban Development (HUD) Grant

HUD Grant Update

- Funding of \$1,000,000 over a three-year period was officially granted to the health department on February 11, 2022.
- Health department worked with county procurement to post the Request for Proposal.

Dental Clinic and School-Based Dental Program

- The Dental Clinic strives to improve the oral health of children ages 1 -20 on Medicaid and pregnant and postpartum women who are Medicaid eligible.
- The School-Based Oral Health Program, in partnership with HCPS, has resumed its services in 10 Title I Schools.
 Dental education is provided to all classes and direct dental services are provided with parental consent.





WIC at 1 N. Main

- The 1 N Main Family Health Center has had <u>approximately 300 WIC participants receive</u> <u>nutritional services since its opening in July.</u>
- This program will start seeing children in the new dental clinic within the next month when we welcome our new tri-lingual Pediatric dentist, Dr. Carolina Rojas.





Harford County Health Department

Medical Assistance Transportation

- Assures eligible Medicaid participants
 access to care by providing non-emergency
 ambulatory, wheelchair, and ambulance
 transportation to health care appointments.
- Additionally, the program covers return trips from hospital emergency visits, return trips from hospital stays, and medically necessary inter-hospital transfers.



Clinical Health and Hepatitis C

- Hepatitis C is a leading cause of liver cancer.
- 47,000 73,000 Maryland residents will contract Hepatitis C in their lifetime.
- 1 in 3 young people who inject drugs have Hepatitis C.
- Reaching more people with hepatitis C and offering testing and treatment is critical to saving lives and preventing transmission of this deadly, but curable, infection.





Health Department

Clinical Health and Hepatitis C

- Over 70 individuals enrolled in care in our Clinical Services Bureau.
- 35 have been cured.
- 14 currently receiving treatment, close to cure.
- 22 lost to follow up (Prevention and cure are low priorities if other issues are going on.)
- Strong relationships with local treatment centers for testing and referrals to our services.
- Once engaged in Hep C treatment, clients utilize other HCHD services such as immunizations, sexual health, behavioral health, drug user health, and family planning.





Healthy Families Harford County

- A free program that provides home visiting services, including prenatal development, parenting, child development, health care, and local resources support, by trained Family Resource and Support Specialists until children reach 3 years of age.
- Healthy Families Harford County holds monthly parenting support groups to share information and provide socialization opportunities for parents.
- All pregnant women and families with children under three months of age, living in Harford County are eligible to be screened for service.





Harford County

Healthy Families (continued)

- Preparing for 2nd Accreditation which is due in July.
- Our home visiting "pilot" program is preparing to end and its success has <u>led to a</u>
 <u>statewide expansion for all home visiting sites to now bill Medicaid directly for home</u>

 <u>visiting services that use Healthy Families America or Nurse Family Partnership models.</u>
- We will begin the expansion in FY23.
 - The goal is to continue to expand our services to more families in Harford County with this funding



Health Department

Healthy Families (continued)

- We had <u>8 families graduate from our</u> program in 2021!
 - 11 families (12 target children) graduating in June 2022.
 - Graduation will take place at MEGAN's Place on 6/16/22.
- We have monthly groups with topics including time management, mindfulness, networking, yoga, and health education.





Lead and Asthma

- Home visiting program led by nurses and community health workers.
- Conduct 3-6 visits in-person or virtually with the family depending on preference. We provide information, education materials, and tools/supplies consisting of:
 - Mattress and pillow covers
 - Medicine containers
 - HEPA Vacuum cleaners
 - Doormats
 - Green Cleaning supplies
 - Pest Management Kits


Qualifications:

- Resident of Harford County
- Enrolled in/meet eligibility for Medical Assistance
- Ages 0-18
- Have a Blood Lead Level of 5 μg/dL or higher and/or
- Moderate to severe Asthma diagnosis



Environmental Health

- Three Program Areas
 - Inspections
 - Permits and Plan Review
 - Land and Water Resources
- All EH inspectors must have at least a Certificate of Eligibility from the Board of Environmental Health Specialists for employment at a local Health Department
 - Bachelor with at least 30 science credits
 - At least 12 month training period
 - Must pass national licensing exam before In-Training Certificate expires (3 years from date of hire)

Spotlight: Peach Bottom

Constellation Peach Bottom Atomic Power Station Exercises

- The Health Department participates in radiological FEMA graded exercises every two years to demonstrate our partnership with various county and state agencies in the event that there is a release of radioactive material.
 - 1. Participate in **Emergency Operations Center** exercise to demonstrate actions we would be taking during various stages of a possible radioactive release and how we would be utilizing our partnerships to accomplish these tasks.
 - Participate in a Radiological Monitoring and Decontamination exercise that demonstrates how we would operate Community Reception Centers.









Spotlight: Peach Bottom

Potassium Iodide (KI)

- A salt of stable iodine in pill form. This can be ordered by the County Health Officer for protective action.
- What is iodine? Iodine is essential for proper function of the thyroid gland, which uses it to make the thyroid hormones.
- What is it used for? The FDA has approved it as a nonprescription tablet for use as a "blocking agent" to prevent the human thyroid gland from absorbing radioactive iodine (radioiodine).
- What is the thyroid gland? Largest gland in the neck and secretes metabolic hormones important to the growth of the human body.
- What is radioactive iodine? One of the most abundant substances in the cloud of radioactive steam released by a failing nuclear power plant.









Spotlight: Peach Bottom

Maryland Risk County

- Receives automatic ring-down call into the 911 Center reporting G.E.
 - Contact the County Emergency Manager
 - Activates the EOC to a level-1 (Full)
 - First responders alerted to report to Staging Area for RAD Briefing
 - · Reception centers and initial mass care shelters are opened
 - Join conference call with MEMA and MDE
 - Activate the siren system and provide appropriate EAS message
